## **Combining Fostering and Adoption**

Phil and his wife share their experience of adopting their son through Coram's Concurrent Planning.

"Our son is the light of our lives. He first came to live with us in a foster placement through Concurrent Planning.

Concurrent Planning ensures a child finds a settled foster placement while the family courts consider the longer term outcome. This could be adoption or it could mean the child returns to their birth parents; whatever the court decides is best for the child.

The centrality of the child's needs in the process is what attracted us to concurrent planning. We wanted the opportunity to care for a baby as young as possible and to be the ones there through the early stages of development.

The first step was a phone call to Coram. Following a meeting with them, being assessed and attending a number of training sessions we were awarded concurrent care status.

The next step was a phone call telling us the details of a one month old baby who had been referred for concurrent care. After great discussion and a visit from the baby's social workers we were able to meet him.

As soon as we saw him, he was all we could focus on. He was so cute with the most amazing smile, we just couldn't wait to hold him. We immediately fell in love with him and felt so proud that



we had been chosen to be the ones to give him a good start in life.

Our job for the next 6-9 months was to foster him, and bring him into contact with his birth parents.

We always prepared ourselves for the eventuality that his birth parents might overcome the circumstances leading to him being removed. Sadly they couldn't, and the courts granted a placement order and we adopted him.

As his foster carers we were in the ideal position to then become his permanent family. For us it was wonderful. Again, Coram was there for us, in areas we

hadn't even anticipated, for example the introduction to extended family, play dates and being able to call them at any time.

As every parent knows, however amazing you think family life is going to be, that preconception is dwarfed by the wonder of the real thing.

Yes – the life our child has is special compared to the life he may have had, but he gives us so much more in return. Concurrent care is highly demanding, but the end result has been nothing short of transformational. Our son is beautiful, active, intelligent, hilarious and loving, and we couldn't be happier."

## **Foundling Stories**

In 1942 Doris was brought to the Foundling Hospital, as Coram was known then. She explains how her story was quite unique.

"I arrived at the Foundling Hospital with my birth mother in 1942 at the age of just 6 months. Before coming to the Foundling Hospital my mother and I had travelled around a number of work houses but my mother soon realised this was unsuitable for raising a child so she brought me to the Foundling Hospital to give me the chance of a better life and an education.

Upon arriving at the Foundling Hospital I was baptised and foster parents were found for me to stay with. I was taken home with them to Saffron Walden the same day."

It was the norm for Foundlings to stay with foster parents until the age of five when they would return to the Foundling Hospital to live and attend school until the age of 15.

"I was always made aware that one day I would have to return 'home' but I was never sure what this meant. Where was home? I grew up knowing I wasn't theirs and that at some point I would be sent back. This uncertainty left me feeling very insecure and whenever I had a new pencil or comic I would take it with me just in case I was sent back."

Doris never had to return to the Foundling Hospital as at the age of seven the Foundling Hospital agreed to let her foster parents adopt her.

"When the adoption was being finalised in court I remember seeing my birth mother and I was very wary of her. I remember clinging on to my foster mothers arm as I still wasn't sure what was happening to me and I didn't want to be taken away from them."

Doris was one of the first Foundlings to be adopted and feels she was very lucky to be given the chance of a better life and to avoid the trauma many Foundlings went through of being separated from their foster families and being sent back to the Foundling Hospital.

"I don't just owe Coram for my upbringing and a roof over my head; I owe him for a family."

## **Adoptables Schools Toolkit**



For an adopted child, school life can be difficult. Friendships, relationships, and even certain lesson topics can raise areas that can be sensitive or challenging for them.

In May this year we launched a toolkit to improve the school experience for adopted children and young people. In consultation with teachers, this resource was developed by Coram Adoptables which is a peer network of adopted young people.

The Adoptables Schools Toolkit uses fun, interactive lessons to help teachers and students understand some of the issues that adopted children have to cope with.

It has had very good feedback with 95% of Key Stage 3 class participants rating the toolkit as good or very good. We're very excited about it and really believe that it will improve the school experience for many adopted children.

### A day in the life...

Hello. My name is Sara Gomes and I am an Advocacy Coordinator for Coram Voice. It can be extremely difficult for a vulnerable, young homeless person to navigate the complex bureaucracy of local authority housing, and that is what I and my team at Coram Voice help them with.

Today I went straight to a homeless shelter in Kings Cross where I spoke with four young homeless people. Three of them had been in care as a child and now, through one reason or another, found themselves living on the streets. Often these young people don't even know that they are entitled to any help at all.

I'll speak to their Local Authorities and ask them to re-assess their cases. They really should be classed as care leavers who should be provided with suitable accommodation.

Getting back to the office I caught up on emails and my existing caseload.

Then I sat down with the advocates that I supervise and we talked about their cases.

Before I could leave for the day, I got an urgent email about a young pregnant woman who was supposed to be moving into accommodation that day, but it is now no longer available.

Every day is different; some are less complicated, but some are much more so. It can be a very difficult job, but it is also the most rewarding. Helping a young person get a new start in life give me an incredible feeling, because I know I have made a huge difference.

# A lasting legacy

Some consider it a difficult topic of discussion, but making a Will really shouldn't be. In fact it is incredibly important because without a Will you cannot be sure that your wishes will be carried out when you die.

Mrs Morris knows this and already had a Will, but when her circumstances

changed she wanted to update her Will. She wanted to make sure that after she had taken care of her loved ones, the causes that she supported were remembered as well.

"My family knows I support a few charities, but they don't know which ones and why. Coram is one of my favourite charities. I believe in Coram's positive and supportive attitude in helping children and their adoptive parents."

Making a Will gives peace of mind because it makes sure that what happens to your estate is exactly as you would want it.

It is also a good time to think of your favourite charity or charities. Leaving a gift in your Will is a wonderful way to show how much you care and is a lasting legacy. Your kindness continues even after you die. As Mrs Morris says, "I cannot do a great deal after I go, but that much I can do!"
